INFORMED CONSENT

Student Focus Group Interview

I am volunteering for a research project about student learning from participation on a SoTL research project team. If I choose not to participate for any reason, there is no penalty. If I choose to participate and then decide at some point in the future not to participate, I may withdraw consent without any type of penalty.

This research involves:

- 1) A 60 minute focus group discussion with other students that will be audiotaped. [These tapes will be transcribed and data stored on a flashdrive and on two different computer hard drives. The interviewer will keep the interview data until the research and associated products are completed.]

There are minimal risks associated with this study because it is confidential but not anonymous and the focus group questions are both personally and academically related. Risks may include learning something about other students' experiences with the research project that you did not have and wish you had. What participants say in the group discussion will be heard by other students but participants can limit their responses as they choose to minimize that potential risk.

Others may benefit by hearing about your experiences with this SoTL research project. You may benefit by reflecting and discussing you own learning with other students. No one except the researchers will have access to the interview data or audio tapes.

You are not obligated to respond to questions you do not wish to answer and may withdraw consent for any reason at any time if concerns arise as a result of your participation in this voluntary research study.
